

Jean K. Freeman Aquatic Center Long Course Event Operations – COVID-19 April 1, 2021

Key Safety Protocols

- ★ Facility capacity is 382 people
 - The only exception to this count is "staff", hereby defined as: University Staff, Host Team Event Staff (up to 3), and Officials.
 - Athletes, coaches, volunteers, and other positions not defined, all count towards the 382 capacity.
- ★ The deck capacity not to exceed 115.
 - University Staff, Officials and Host Staff will station on-deck positions at least 6 feet apart.
 - All staff, coaches, volunteers, officials, and anyone else in attendance will be required
 to wear masks at all times. Athletes will be required to wear a mask at all times until
 immediately before they enter the water.
 - Anyone in the facility who has to be reminded more than three times about mask adherence will be asked to leave the facility.
 - All staff, coaches, officials, volunteers and athletes will be screened prior to entry using the Minnesota Department of Health's <u>Facility Health Screening Questionnaire</u>.
 - Officials and coaches may only use electronic whistles.
- ★ Spectator Seating can be used for athletes or spectators
 - There is space for 246 people, 123 each side, to be spaced 6 feet apart in the spectator areas.
 - Spectators and athletes will NOT be seated on the same side.
 - Locker rooms may be accessed for restroom use and changing only. To maintain proper distancing, only six (6) people will be allowed in the locker room at a time.
 - Changing rooms are available upstairs for athletes. There are 44 of them.
- ★ Meet organizers may provide live streaming of the event should they choose. They are required to connect with the facility at least 72 hours in advance to discuss setup needs.
 - Alternative displays of good sporting conduct will be encouraged. No handshakes, highfives, hugs, excessive cheering, etc. will be allowed.

- In the Assumption of Risk Statement by USA Swimming, please include the University of Minnesota.

- In the Time Schedule, please include:
 - "The facility, including spectator area and lobby, will be cleared after each session for a 30 minute cleaning period."
- Please include the following statement: "The University of Minnesota Staff reserve the right to remove anyone from the facility who does not comply with safety measures."

Operations:

Ingress/Egress

- The host team must manage ingress/egress at all times the doors are unlocked
- Outside doors can lock at a predetermined time once all athletes and personnel have entered and remain locked for the duration of the event. If anyone requires re-entry during the event this must be arranged with the organizer.
- ★ We suggest staggered entry times to reduce congestion in the Lobby
 - Check in tables will administer health screening as well as direct athletes to their spot.
 - The host team must staff and manage ingress/egress to ensure capacity limits are kept.

Seating

- ★ Please use the Long Course Capacity Map to see capacity limits of each seating area
- ★ Athlete seating may be on deck and/or in spectator seating.
- ★ Spectators and athletes may not be seated on the same side of the spectator concourses.
- ★ If spectators and athletes are seated upstairs, there needs to be host team staff monitoring entry to seating areas.
 - A staff member or responsible volunteer will be assigned to the spectator seating area to help enforce social distancing and mask adherence.
 - Coaches will have bleacher space available to sit and keep their belongings. For meets with athletes under the age of 18, a coach (or adult representative if no second coach is available) from each team must be seated in the spectator area with their athletes.
 - Timers and other volunteers will have space in the Wet Classroom to keep their personal belongings.
 - Officials will be given space in the Dry Classroom for their personal belongings and breaks.
 - Meet staff will be divided between the Event Office, Meet Management, and the deck.

Warmups

- ★ For events that exceed 96 swimmers, warm ups must happen in multiple sessions.
- ★ Maximum lane capacity will be:
 - o Competition Pool: 8 Swimmers/Lane
 - Diving Well: 5 Swimmers/Lane
- ★ The following are the pool capacities for warmups:
 - o Competition Pool: 64 Swimmers
 - o Diving Well: 30 Swimmers
- ★ Starts:
 - Host Team should assign start lanes and swim back lanes
 - ★ o Coaches should direct their swimmers to swim back in another lane rather than walk on deck maskless.

Racing

- We recommend using the North side deck as a staging area for upcoming heats
- We recommend restricting coaches the South side deck to keep a one-way flow.
- ★ No more than 4 relays per heat to keep a lane separating each relay team.

Cleaning Procedures

HDQ Neutral Disinfectant (EPA 10324-15) in spray bottles ●

The bleachers will be cleaned at the end of each day.

- Doors that can, will be propped.
- Hand sanitizer bottles will be provided in any high touch point areas such as by doors that cannot be propped open.
- The facility will be cleared for 30 minutes so spectator areas and all touch points can be cleaned thoroughly before any new sessions
